

Information for Application Submission in SlideRoom (Ohio STEM and STEAM Designation)

It is beneficial to review the STEM and STEAM designation rubric prior to starting the submission process to prepare the necessary artifacts. The rubric is not available on the online platform. We recommend printing out the rubric and referring to it continuously throughout the application process.

Accessing Application

- To begin your application, please visit osln.slideroom.com.
 Only school or district leadership are permitted to create a SlideRoom account for the school applying for designation.
- You will be prompted to create a login using the "Sign Up" button on the top right. Please create one login for your school and share it with anyone who may need access.
- Once you create a login, you will see a landing page with the four separate applications that
 need to be submitted: one capturing the general information about the school, and the other
 three corresponding to three domains of the STEM and STEAM Designation Rubric: Domain I:
 Culture for Learning, Domain II: Learning and Teaching, and Domain III: Pathways to Success
 in Careers.

- Applications can be completed in multiple sittings. Your work should be saved automatically as
 you progress through the questions, but you can also click "Save" in the bottom left corner.

Artifacts and Narratives

- According to the federal Family Educational Rights and Privacy Act (FERPA), schools are
 prohibited from sharing personally identifiable student information without a parent's
 written consent (except in very limited circumstances). Therefore, please be sure that
 you are not including student information such as names and student numbers in your
 application or artifacts. Please redact this information before submitting your application
 in SlideRoom.
 - Any application in violation of FERPA will be returned to the applicant. This may impact your school's STE(A)M designation process.
- For most of the subsections, you will be asked for artifacts and corresponding narratives.
 Artifacts are defined as forms of evidence that can be used to showcase educational practices.
 Artifacts can take on various formats, including but not limited to documents, videos, images, flyers, news stories, reports, publications, forms, applications, spreadsheets, etc.
- Please note the acceptable file sizes when uploading files to the online platform (SlideRoom):



- o Images must be under 5 MB
- You can upload images with any dimensions, As SlideRoom resizes images larger than
 1280 x 1280 x 72 ppi
- Videos must be less than 250 MB in size. To include a video larger than 250 MB, upload it to YouTube and add a link to a pdf document. Upload the document with the link as your artifact.
- Audio files must be less than 30 MB in size. Documents must be less than 10 MB
 Images and videos are subject to be compressed to be displayed properly in SlideRoom.
- Live links cannot be submitted as artifacts. For example: artifacts in Google Suite (Docs, Slides, Sheets, etc.) or any platform where artifacts can be changed after submission, will not be accepted.
- Live links included in artifacts will not be considered. In other words, any link included in an artifact which leads to another site, will not be considered.
 - Exception: To include a link to a video (YouTube, Vimeo), create a pdf that includes the link ONLY and submit that pdf as your artifact.
- Please note that several artifacts are required to be submitted as part of the application. These
 required artifacts do not count toward the allotted number of artifacts for the attribute.
- One artifact can include multiple documents, as long as the documents are related and present evidence of the same practice. Documents can be merged as a single pdf file.
- If appropriate, the same artifact can be used as evidence for multiple attributes.
- Most of the artifacts need to be accompanied by a narrative. The narrative needs to specifically
 address how the artifact demonstrates a particular attribute. The same narrative cannot
 accompany the artifact that is being used in multiple parts of the application.
- Narratives are required for the majority of artifacts. Artifacts that are not accompanied by a required narrative will not be considered.
- Most narratives are limited to 900 characters (approximately equivalent to 150 words). There
 are several questions in the application that require longer narratives. Those responses allow
 for a higher character count.
- Please do not use the media or portfolio components of the platform. Any artifacts
 uploaded in the medio or portfolio section of SlideRoom will not be considered during the review
 process.



Submitting Application

- The review team will not see any of your responses until you click the "Submit" button for each application.
- You will receive a confirmation email from SlideRoom once you have applied.
